



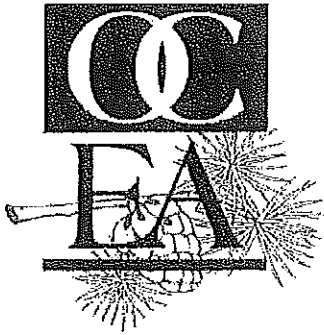

SUBJECT: Close Out of the Community Development Block Grants for the 2011 DDA Pavilion on Court Improvement Project

DATE: March 26, 2012

In compliance with Community Development Block Grant close out requirements a public hearing must be held to take public comment on the completed projects.

A summary of the final costs for the CDBG funded Pavilion on Court improvement project completed in 2011 is shown below. This project supported the installation of infrared heating, retractable canvas sides, and other associated improvements to the Pavilion on Court in the downtown business district.

Now, therefore, I, John E. Jenkins, Mayor of the City of Gaylord, do hereby proclaim April 27th, 2012, as

Arbor Day

in the City of Gaylord, and I urge all citizens to celebrate Arbor Day and to support efforts to protect our trees and woodlands, and

Further, I urge all citizens to plant trees to gladden the heart and promote the well-being of this and future generations.

SOCIAL WORKERS



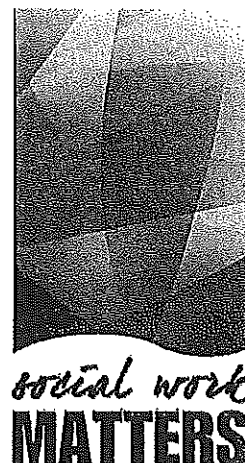
