Mayor Jenkins opened the regular meeting of the Gaylord City Council with prayer by Council Member Wishart at 7:00 p.m. on Monday, February 11, 2013, in the City Council Chambers, located in the Gaylord City Hall, 305 East Main Street, Gaylord, Michigan. The Pledge of Allegiance followed the invocation.

Motion by Campbell, supported by Wishart, to dispense with the reading of the minutes of the previous meeting and to accept them as presented.

Motion by Duczkowski, supported by Johnson, to approve the City's portion of the Otsego County Fire Board budget in the amount of \$63,227 and to enter into an agreement with the Otsego County Fire Board for services commencing July 1, 2013 through June 30, 2014. The City Manager is authorized to endorse the agreement on behalf of the City.
